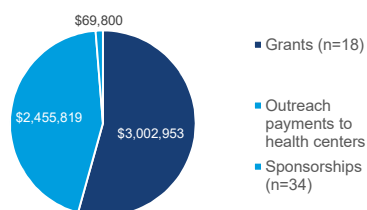

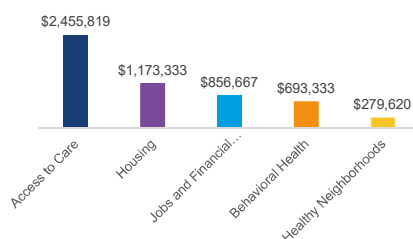

Community-based Health Initiative Boston Cohort Updates

- External evaluation data from July 1, 2021 – September 30, 2022
 - Total number of participants enrolled: 816 (386 BH, 345 Housing, 284 Jobs)
 - Staff hired: 45; Staff/volunteers trained: 345
 - Half of participants identified as Black or African American (49.4%); the next largest group of participants identified as Asian (23.9%)
 - 23.4% of participants identified as Hispanic, Latino, or Spanish ethnicity
 - Almost a third of participants (30.3%) indicated a primary language other than English; largest group of participants primarily speak Chinese (17.3%)
 - Among the three grantees reporting incarceration data, more than half of participants indicated they have a history of incarceration (55.4%)
- Evaluation learning collaborative topics this year have included interactive quantitative and qualitative data collection sessions and grantee spotlights
- First detailed evaluation summary will be available spring 2023 (will include 1.5 years of implementation data and preliminary outcome data for overarching evaluation)

Illustrative Participant Stories from Grantees

"Tommy (name changed) is a 50 year-old individual who joined the Teaching Kitchen program...just two months after coming home from 17 years of incarceration...Community Servings helped him to access SNAP benefits, a monthly T pass, housing support, financial empowerment coaching, computer classes, and consistent sources of food and meals. While attending the Teaching Kitchen program, the hourly wage was a lifeline for him as he met his basic needs and supported his loved ones. He earned two Servsafe certifications and became employed with a major restaurant soon after graduating from the class."

"One client... was involved with DCF and family probate court due to significant co-parenting struggles. He was matched with a coach and worked through 12 weeks of parenting class, 14 weeks of managing emotions groups, regularly worked with a clinical therapist, and worked with the therapeutic coaching department...He successfully got his kids back and his DCF case closed and he is now more engaged in his children's lives. He found full time employment and is still hoping to pursue his passion for cooking someday."

Healthy Neighborhoods Initiative (HNI) Updates

Chinatown HOPE (Health, Opportunities, Possibilities, Empowerment) Collective:

- Community engagement included dot voting at Chinatown Block Party, focus group with long-time residents in Chinatown, and survey sent to over 600 residents
- Awarded funding to decrease social isolation and increase community cohesion by activating open space in Chinatown through gardening, arts, cultural programming and resident leadership development

Chelsea Healthy Neighborhoods Initiative Collective:

- Community engagement involved voting at four community events and two focus groups conducted in English and Spanish, with Arabic interpretation available
- Awarded funding to develop and implement Women's Wellness Workshops to improve the overall health of women in Chelsea. Long-term goals include reducing stigma and shame, decreasing isolation, and developing self-advocacy skills

Holding a meeting in January 2023 with both cohorts of Collectives to share lessons learned and inform the final HNI RFP, for Allston/Brighton, Mission Hill and Roxbury, to be released February 2023

Community-based Health Initiative Chelsea Grant Updates

- North Suffolk Mental Health Association awarded ARPA funds to enable continuation of Latino CART program for additional 2 years
- La Colaborativa has served 23 youth in their jobs program to date with BIDMC funding (out of 67 total)
- Comunidades Enraizadas Community Land Trust (CE-CLT), a community land trust created by a group of primarily Latina immigrants living in Chelsea, will begin the planning phase of a 4-year grant in January 2023

Hospital Community Benefits Advisory Committee (CBAC) Role

- Advisory body that supports the hospital in its community outreach and engagement work
- Regulatory requirement of Attorney General's Office and Department of Public Health Determination of Need (DoN) for each hospital
 - Intentionally independent from hospital Board of Trustees and management
 - No formal fiduciary or governance responsibility
- Provides input to hospital leadership and staff on:
 - Community Benefits mission statement
 - Community engagement
 - Community Health Needs Assessment (CHNA) design and Implementation Strategy prioritization and implementation
 - Advises hospital on Community Benefits programming including DoN projects
- Reviews regulatory reports

Regulatory Update

Hospital Community Benefits Advisory Committee (CBAC)

Hospital CBAC must meet the following membership requirements (per BILH, AGO and DPH requirements)

- Housing
- Jobs/Education
- Regional Planning / Transportation
- Private sector
- Community-based organization
- Local Public Health Department
- Other municipal staff (such as elected officials, planning, etc.)
- CBSA demographic and geographic representation
- CBSA resident
- Behavioral Health
- BILH Primary Care
- Hospital Senior Leader and/or Board of Trustees (or designee)

Regulatory Update

Summary of Significant CBAC Charter Changes

- Added to Membership section: Person with knowledge of and expertise in the area of behavioral health
- Updating language to clarify that meetings can be held remotely or in-person
 - When meeting remotely, expectation is that members participate with video camera on (notify BIDMC if not possible)
- Changed "hard-to-reach" to "historically underserved"

Regulatory Updates

Conflict of Interest (COI) Statement

- **Purpose:** Protect the integrity of the CBAC's decision-making process
- **Disclosable Interests:** Volunteer or governance roles (e.g., Board of Directors seat), compensation arrangements (e.g., Employer or consulting client), material ownership or investment interests (e.g., holding stock, being a part-owner); intention to apply for or currently receiving BILH or BIDMC grant funding
- **Timing:** Upon joining the CBAC, annually, and/or when your situation changes (ad hoc)
- Disclosures are not necessarily conflicts of interest
- BIDMC considers COI disclosure statements to be a best practice
- **Next Step:** COI will be emailed to you following today's meeting

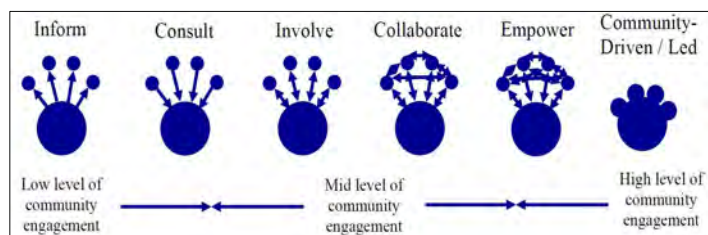

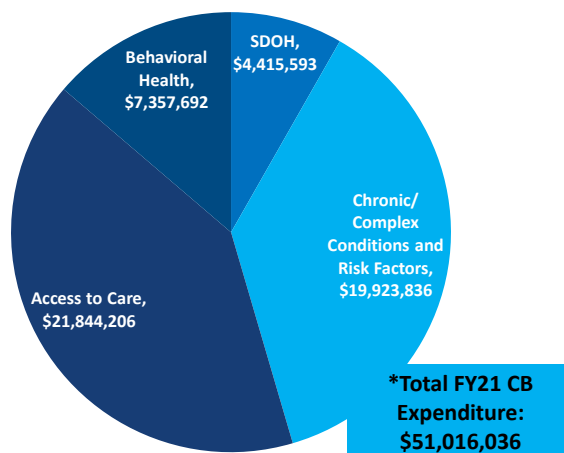

Regulatory Update

Access to Birth Centers Grant Opportunity

Funding to create, expand, or reopen birth centers

BILH will provide \$1.5 million in financial support to one or more community organizations to create, expand, or reopen birth centers licensed by the Massachusetts Department of Public Health

Such centers would prioritize unmet needs for maternity care in underserved communities

Funding could be made available for capital and infrastructure needs through grant applications, similar to awards provided through BILH community health investment awards

Available for application beginning January 2023 through December 2025
